

Saint Francis Hospice New Year Raffle

MAIN RAFFLE RULES

Restrictions: Entry is by invitation only, among residents of Great Britain. Tickets may not be sold by or to any person under the age of 18. Any person found to be under 18 will automatically forfeit any prize they win. Tickets must not be sold in the street.

Draw date: The raffle closing date is 5pm on Thursday 7th March 2024. The raffle will be drawn on Thursday 14th March 2024. Each ticket costs £1. Payments may not be made by credit card or Charity Voucher. Cheque, debit card or cash are accepted forms of payment. Names will be drawn "out of a hat" from all ticket stubs purchased. You may purchase up to £100 worth of tickets for the New Year draw. Any ticket sales above this amount will need to be agreed by the Promoter. The list of winning ticket numbers will be available on our website following the draw.

Prizes: First prize is £4,000 cash or £4,000 of Travel vouchers (winner can choose a cruise or any other holiday); Second prizes (4 to be won) is £400 cash or £400 of Travel vouchers (winner can choose a holiday in the Cotswolds or in any other location). Third prizes £40 (25 to be won). All cash prizes will be paid by cheque.

Notification of winners: Winners will be notified in writing or by phone within 10 days of the draw date. A list of winning numbers will be provided upon receipt of a stamped addressed envelope. Where we are unable to contact a prize winner so that a prize remains unclaimed for six months following our first attempt to notify the prize winner, we may apply the prize as we see fit, including re-offering the prize in future raffles.

Late entries: Tickets received after the closing date will be treated as a donation.
